NOTE:

- You must be in possession of a passport valid for at least 6 months after trip return date.
- No visa required for Canadian passport holders to visit France.
- Starting in late 2026, the European Union is expected to launch the European Travel Information and Authorization System (ETIAS). ETIAS will require travelers from visa-exempt countries, including the United States and Canada, to obtain travel authorization before entering most European countries. It is not a visa, but a pre-screening process intended to enhance border security across the Schengen Area. We will provide more detailed information and guidance if and when the ETIAS program officially comes into effect.
- Please note names provided at time of booking MUST exactly match your passport.
- Entry to another country may be refused even if the required information and travel documents are complete.
- Living standards and practices at the destination and standards and conditions there with respect to the provision of utilities, services and accommodation may differ from those in Canada.
- No price increases are permitted after the customer has paid in full. If the price increase is more than 7% (except for increases resulting from an increase in GST/PST/HST), the customer has
